3. Entrant agrees that only drivers with current race driver credentials, issued by their sanctioning body, shall be permitted to drive the car during the Test Day.
4. Entrant agrees that only properly credentialed crew will be permitted in the hot pit area during the Test Day.
5. In consideration for being permitted to participate in the Test Day Event, Entrant agrees to permit NJMP the use of their name, voice and/or likeness, and images of the Driver, Crew and/or Team Cars for news, publicity, and feature use including radio, television, motion picture film, newspapers, magazines and any and all other media as deemed prudent by NJMP.
