**REGISTRATION**- ALL carts, scooters and similar vehicles driven on site must be registered and require a permit, whether owned or rented. Any vehicle on site without proper permit is subject to impound at owner's expense. Permits for approved users will be distributed and/or available for pick-up at the Credential Office located at the corner of 77<sup>th</sup> Street and Greenfield Avenue.

### **On Site Parking Locations – see attached map**

#### **Pit Lane:**

- No motorized vehicles are allowed in the Pit Lane or Gasoline Alley area except for official team tow cars
- There is NO designated parking behind Grandstands. All passenger golf carts and scooters must be parked in the paddock
- Any vehicles impeding spectator flow will be removed at the owner's expense

#### **Hospitality & Driver/Owner Motor Coach Paddocks:**

- All carts and scooters must be parked WITHIN your designated coach space
- Any vehicles parked in the fire lanes will be removed at the owner's expense.

#### **OUTSIDE THE TRACK**

- Any golf cart outside the track MUST get a permit from the Wisconsin State Fair Park – see attached form
  - This form must be filled out and submitted directly to the Wisconsin State Fair Park
  - The Golf Cart Permit fee is \$52.80 and must be paid directly to the Wisconsin State Fair Park
- Scooters (or other motorized vehicles) are NOT permitted outside the track unless they are licensed motorized vehicles. Non-licensed scooters are NOT permitted under any circumstance.
