



Wisconsin State Fair Park Golf Cart Policy

The 2011 Golf Cart Permit rate is \$50.00 plus tax of \$2.80 (\$52.80) per event permit and \$75 plus tax of \$4.20 (\$79.20) for an annual permit. Permits for the 2011 Wisconsin State Fair and other events can be ordered at any time before the Fair. All requests should be made directly to the Wisconsin State Fair Park RV Park. This policy applies to the annual State Fair and any other events outside the annual Fair.

All permit holders **must** furnish a certificate of Public Liability Insurance from an approved carrier; of at least \$1,000,000.00 combined single limit, and naming the Wisconsin State Fair Park, State Fair Park Board, their Directors, and its employees as additional insured. The insurance certificate must be presented **at the time, or before** the permit is issued.

All operators using the golf cart(s) are to read and sign a copy of the attached *Rules for the Operation of Golf Carts & Other Types of Motorized Vehicles*. All permit holders must furnish a list of persons they wish to have included as operators of carts for which they have permits. Please submit the signed copies of this form for all operators with your golf cart authorization request. In the event a permit holder wants to add persons to the list of authorized operators, those operators must read, sign and file a copy of the rules with the Wisconsin State Fair Park prior to operation.

Rules for operating motorized carts & other types of motorized vehicles

By Wisconsin State Statutes, Motorized Carts Are Considered Motor Vehicles And The Roadways In Wisconsin State Fair Park Are Considered State Highways. **PLEASE ABIDE BY THESE RULES.**

1. Each cart **must display a valid permit on the front of the vehicle** issued by the Wisconsin State Fair Park.
2. All Operators **must** be at least 16 years of age and **must** possess a valid drivers license.
 - a. If an operator has a valid drivers license from another State - his/her Wisconsin driving privileges must be valid and not be under revocation or suspension in the State of Wisconsin.
3. The number of riders on a cart **shall not exceed** the number of seats on the cart.(i.e., 2 seater =2 people; 4 seater=4 people)
4. All Operators **shall** obey all traffic signs & laws throughout the Wisconsin State Fair Park. **MOTORIZED CARTS ARE NOT TO BE OPERATED OFF WISCONSIN STATE FAIR PARK PROPERTY.**
5. Carts must be driven at a reasonable speed for the conditions in the area of operation.
6. Keys are not to be left in any cart while the cart is unattended.
7. **NO ONE SHALL OPERATE A CART OR ANY OTHER MOTORIZED VEHICLE WHILE UNDER THE INFLUENCE OF AN INTOXICANT, CONTROLLED SUBSTANCE, OR ANY OTHER DRUG.**
8. **NO PASSENGER OR OPERATOR SHALL CONSUME R POSSESS ANY OPEN INTOXICANTS ON ANY CART OR MOTORIZED VEHICLE WITHIN THE STATE FAIR PARK.**
9. The cart's speed control, known as the governor, **shall not** be tampered with or removed. Such action may result in additional charges (costs) to the permit holder.
10. **The Permit Holder shall not allow** unauthorized person(s) to operate any cart or vehicle.
11. Carts or other types of motorized vehicles **shall not** be operated in **RESTRICTED AREAS**
12. **All persons** using or operating any cart or other similar type motor vehicle within the Wisconsin State Fair Park must read, sign and file a copy of these rules with the Wisconsin State Fair Park RV Unit.

ANY VIOLATION OF THE ABOVE RULES COULD RESULT IN REVOCATION OF YOUR PERMIT / AUTHORIZATION TO OPERATE VEHICLES WITHIN THE WISCONSIN STATE FAIR PARK, AND / OR ISSUANCE OF A WISCONSIN STATE UNIFORM TRAFFIC CITATION FOR SAID VIOLATION.
